## 4. FIRST AID MEASURES

First Aid:	<p><b>Ingestion:</b> DO NOT INDUCE VOMITING. Rinse mouth immediately after ingestion. Give lots of water to drink. ## 5. FIREFIGHTING MEASURES

Fire and Explosion Hazard : Reactivity	On heating: release of toxic/corrosive/combustible gases/vapors (ammonia). On burning: release of toxic and corrosive gases/vapors (nitrous vapors). ## 7. HANDLING & STORAGE INFORMATION
